Senate Committee Approves FY 2017 Agriculture Appropriations Bill

The Senate Appropriations Committee met today and approved the FY 2017 Agriculture Appropriations bill. As in the House version, this legislation fund the Agriculture and Food Research Initiative at \$375 million, a \$25 million increase from last year’s spending level. Also, the Crop Protection/Pest Management funding level is \$20 million, a \$2.8 million increase.
